- 5. Partner Update Alejandro Manga Tinoco 7:05 This had been moved to the start of the meeting due to him joining us from Namibia. He has worked on Mobility Justice in numerous countries, and he provided a historical timeline on that matter.
- 6. Annual Report Review 7:30 This is now finalized and online, so all are encouraged not only to read it but also to share it!
- 7. 2024 Budget 7:55 Trevor provided a summary, as attached. This summarized budget was approved. (Mark-1, Amy-2, unanimous with one abstention)
- 8. Committees & Strategic Plan Goals Update 8:00
 - a. Volunteer Committee Goal #1: Grow and Support our Volunteer Community Mark said that potential social events are being considered so contact him if you've an idea. Others that have joined the Committee include Eitan, Carina and Daniel.
 - b. Building Committee Goal #2: Improve Functionality of our Building *Amy said they haven't met, although design work is continuing on the potential ramp on 24th Place. The vacant building next door is expected to be listed soon.*
 - c. Communications Committee Goal #3: Improve Communications & Storytelling Devon said they're assisting to hire a social media manager. Also, Board and Staff members are invited to provide photos and a short bio for the webpage, if desired.
 - d. Goal #4: Institutionalize our Commitment to Equity and Social/Racial Justice Trevor reported that the Restorative Justice program with Precious Blood Ministries has been completed, including a four-day facilitator training workshop for Franscisco and himself.
 - e. Executive Committee Goal #5: Advance our Leadership; Local, National, Global Dave said that onboarding will be conducted for the newly elected Board members

Additional Business 8:25 Dave said that a New York law firm has offered pro-bono services to review our bylaws and offer suggestions based on best practices based on their experience with many nonprofits. A Bylaws Committee will be established to work with them so anyone interested should contact Trevor. Any suggested changes would be reviewed by the Board and brought to the next Annual Meeting for a vote. The Bylaws are currently version 19, being last revised in 2022 to increase the size of the Board to allow more representation.
